

**Pennsylvania Education Scholarship Award**

**Provisions of scholarship award:**

1. One (1) award in the amount of \$500 or \$250 will be provided to cover education expenses.
2. The course must be insurance related or necessary for advancement within the insurance industry (i.e. required course for business degree program).
3. Winners of scholarship awards will be presented with a certificate at Council Day. To redeem their scholarships, they must submit in a timely manner one of the following to the PA Council Education Committee Chair for a class or course taken or to be taken no later than one (1) year from the date of presentation.
  - A copy of their paid class/course receipt –**OR**-
  - A copy of the class/course registration form with a request for Council to forward it to the course provider with a check\*Extensions may be granted at the discretion of the PA Council
4. The recipient of the scholarship award shall not be eligible to receive the award again for five (5) years.
